ANNEXURE I

1. Attempt **ANY TEN** of the below mentioned Questions
 2. The details of the parties, etc. are to be written in the drafts.
 3. Assume necessary facts.
-
1. Draft a complaint for dishonour of cheques. Kirtibhai is into a business of tailoring suits. He is a specialist in it. Tiger Group of College engages his service for stitching suits for his students worth Rs.20,00,000/-. Tiger Colleges four cheques of Rs.5,00,000/- each. Which got dishonoured when deposited for clearing by Kirtibhai. Draft a complaint for dishonour of cheques. (Please keep the provisions of The Negotiable Instruments Act while drafting the complaint with regards to jurisdiction, limitations etc.)
 2. Draft an Anticipatory Bail application to be filed in sessions Court. Mr. Don is Accused of running a SPA and Massage Parlour, wherein it is alleged that prostitution is going on.
 3. Draft an Appeal Mr. KALIA is accused of misappropriating money from his company Toran Co. Ltd. Company files a case u/s.315, 316 (2), 420 of Bharatiya Nyaya Sanhita 2023. In the trial Mr. KALIA is convicted. He files an appeal against his conviction.
 4. Draft an application u/s.528 of Bharatiya Nagarik Suraksha Sanhita. Mrs. Sakshi files a case of sexual harassment against her Manager Mr. Benny with Police. Mr. Benny states that the allegation is false and concocted as he had not given her promotion and increment and Mrs Sakshi to teach him a lesson has filed false complaint. He files an application u/s.528 of BNSS for quashing of FIR.
 5. Draft a special leave to appeal in the final judgment and order dated 14.09.2024 of the Hon'ble High Court of Judicature of Bombay in Civil Writ Petition No.5427 of 2024 titled "Vasant S/o Sh. Shankar Bhavsar Versus Digambar & Ors." which was dismissed by the Hon'ble High Court and there is no alternate remedy available.

6. Mr. Ranveer Singh has initiated proceedings at the Hon'ble Bombay High Court against OneDha Broking Limited due to unauthorized transaction in his Dmat account, based on the disputes clause in broker agreement dated 02.12.2020. It is his case that in December 2020 he opened dmat account jointly with his wife Deepika. The last transaction was in January 2022 when his wife passed away. However shares worth Rs. 12 crores were sold in market transactions on 30th June 2022 and were transferred without authority of account holders, on the basis of forged signature on delivery instruction slip. Upon raising objection, OneDha representative informed him that his KYC documents were changed on instructions of account holders and that they were never informed about the demise of Mrs Deepika. Draft a judgment based on the above facts.

7. The Hon'ble High Court passed an order in which Respondent No. 2 Harchand S/o Govinda Telele was given relief based on his deposition recorded before Tahsildar and Agricultural Lands Tribunal Yawal, recorded after remand by Maharashtra Revenue Tribunal Mumbai in his examination in chief, wherein he said that the status of joint family has come to an end in the year 1959. However, in the certified copy of the Order received by Harchand, his name was mis-spelt and also the Tribunal name was wrongly mentioned as Maharashtra Industrial Tribunal. Draft a speaking to the minutes application to correct the above errors.

8. Draft a constitutional amendment bill seeking to empower the Election Commission to conduct elections for Lok Sabha and all State Assemblies at the same time.

9. Shri Vishnu Sathe bought a fridge with, capacity 200 litres from Product Seller R P Enterprises manufactured by product manufacturer M/ s Washclin Public Limited. The fridge failed to start from day one and accordingly Vishnu Sathe brought it to the notice of the product Seller and after repairs the fridge worked only for a day. Despite the malfunctioning which was again brought to the notice of the product seller the product seller refused to replace the fridge. Vishnu Sathe filed the appropriate complaint before the District forum which dismissed the complaint

10. Draft the appropriate first appeal to be filed in the District court at Thane against the judgment and Decree dated 4th March 2024 of the senior division Civil Court judge in special suit number 35 of 2020 decreeing the plaintiffs claim of Rs. 5 lakhs against the defendant/ appellant. Consider bar of limitation, lack of appreciation of evidence and lack of jurisdiction as grounds of appeal.

11. Draft a summary suit where a supplier, having supplied to a developer cement bags worth 50 lakhs based on a mutually agreed contract, faces nonpayment from the Developer. The cement bags were delivered on time and in accordance with the specified quality standards. The supplier, however, is now struggling to receive the agreed – upon payment, of Rs. 50 lakhs from the Developer who is now facing financial strain on his business. Draft a summary suit to be filed in the City Civil Court on behalf of the supplier against the purchaser for the recovery of the outstanding amount

12. Shri Narayan Patil had obtained a loan of Rs 20 lakhs from Shree Ismail Shaikh in Mumbai. Default in repayment having taken place, Draft an attachment before judgment application with a supporting affidavit on behalf of Ismail Shaikh.

13. Mr. Shantaram has obtained a decree for Rs. 30 lakhs against Shree Ramesh. in Mumbai Default in honouring the Decree having taken place. draft an appropriate execution petition for Mr Shantaram.
