3. Footnotes must conform to any authoritative standard rules of legal citation.
4. **The projects shall undergo a review for plagiarism and any evidence of plagiarism found shall result in reduction of marks / non-acceptance of the project.**
5. Font & Spacing Criteria:
 - Font Type (body of the document) - Times New Roman
 - Font size (body of the document) – 12pt.
 - Line spacing option - 1.5
 - Font Type (Footnote) - Times New Roman
 - Font size (Footnote) – 10pt.
 - Margin spacing - 1 inch on all sides of each page.
6. The pages should be numbered appropriately.
7. The Projects submitted should compulsorily contain the following contents:
 - Cover Page
 - Acknowledgment
 - Table of Contents
 - Introduction
 - Body of your Project
 - Bibliography
 - Statutes
 - Books
 - Articles Case
 - Laws

8. The Cover Page of the project must contain the following details:

- Topic of the Project
- Subject
- Name of the Student
- Division & Roll No.
- College Name

9. Students are encouraged to be creative with respect to their submissions.

10. Students may refer to books, research articles, case laws, etc., for writing the projects.

11. Hard copy of Project with spiral binding should be submitted to the college office on or before **21st September, 2026**.
